ARTICLE I - NAME

THE NAME OF THIS CLUB SHALL BE "THE FLYING KNIGHTS OF HAMBURG, NEW YORK, INC.

ARTICLE II - PURPOSE

SECTION 1.

THE OBJECTIVE OF THIS CLUB SHALL BE TO PROMOTE MODEL AIRCRAFT BUILDING AND SAFE FLYING. AND TO AID INSOFAR AS POSSIBLE. THE NATIONAL PROGRAM OF THE ACADEMY OF MODEL AERONAUTICS INC. (REFERRED TO AS AMA) AND OTHER AMA ACTIVITIES, LOOKING TOWARD THE CONTINUAL ADVANCEMENT OF MODEL AVIATION IN ALL ITS PHASES IN THE UNITED STATES.

SECTION 2.

ALL LOCAL OR SPECIAL ENTERPRISES OF "THE FLYING KNIGHTS OF HAMBURG. NEW YORK, INC." SHALL CONFORM TO THE POLICIES OF THE ACADEMY OF MODEL AERONAUTICS, INC. AND ACTIVITIES OF THAT ORGANIZATION GOVERNING MODEL AIRCRAFT ACTIVITIES.

SECTION 3.

THE COLORS OF THIS CLUB SHALL BE: ROYAL BLUE AND WHITE.

SECTION 4

THIS ORGANIZATION SHALL HAVE A SEAL AND A LOGO WHICH SHALL BE IN THE FOLLOWING FORM:

ARTICLE III - MEMBERSHIP

SECTION 1.

ANY PERSON WHO INDICATES AN INTEREST IN THE BUILDING OR FLYING OF MODEL AIRCRAFT OR IN FURTHERING THE PURPOSE OF THIS CLUB, SHALL BE ELIGIBLE FOR MEMBERSHIP IN THE FLYING KNIGHTS OF HAMBURG, NEW YORK, INC." PROVIDED HE MEETS QUALIFICATIONS PRESCRIBED BY THIS CLUB AND BY THE ACADEMY OF MODEL AERONAUTICS, INC., AND HOLDS A VALID AMA LICENSE.

SECTION 2.

EACH MEMBER OPERATING RADIO CONTROLLED MODELS SHALL HOLD AN INDIVIDUAL LICENSE APPROPRIATE TO HIS OPERATING FREQUENCY OF RADIO EMISSION AS REQUIRED BY THE FEDERAL COMMUNICATIONS COMMISSION.

SECTION 3.

TO RECEIVE A NEW MEMBER INTO THE CLUB, THE MEMBERSHIP MUST BE OPENED; A MAJORITY VOTE OF THOSE MEMBERS PRESENT MUST BE ACHIEVED AND THE MEMBERSHIP MUST THEN BE CLOSED. PROSPECTIVE MEMBERS MUST HAVE A SPONSOR FROM THE MEMBERSHIP. (SEE ARTICLE XII - DEFINITIONS)

SECTION 4.

A PROSPECTIVE MEMBER MUST COMPLETE AN APPLICATION FOR MEMBERSHIP AND HOLD A VALID AMA LICENSE AT THE TIME HE JOINS THE CLUB. THE INITIATION FEE ANNUAL DUES AND ASSESSMENT FEE (SEE ARTICLE X - DUES AND FEES) MUST ACCOMPANY APPLICATION

ARTICLE III A - ASSOCIATE MEMBER

SECTION 1.

ASSOCIATE MEMBERSHIP IS AVAILABLE TO THOSE THAT HAVE AN INTEREST IN JOINING THE FLYING KNIGHTS OF HAMBURG, N.Y FOR THE CLUB ACTIVITIES AND SOCIAL ASPECTS OF MEMBERSHIP, BUT HAVE NO DESIRE TO ACTUALLY FLY A MODEL AIRCRAFT AND DO NOT POSSESS AN AMA LICENSE. THEY MAY PARTICIPATE IN ALL CLUB FUNCTIONS AND DECISIONS BUT ARE NOT ALLOWED TO FLY. ASSOCIATE MEMBERS PAY ALL DUES AND FEES OF REGULAR MEMBERS.

ARTICLE IV- OFFICERS

THE OFFICERS OF THE "FLYING KNIGHTS OF HAMBURG, NEW YORK, INC." SHALL BE:

a) PRESIDENT

C) SECRETARY

b) VICE-PRESIDENT

D) TREASURER

ARTICLE V- DUTIES

PRESIDENT:

THE PRESIDENT SHALL PRESIDE AT ALL MEETINGS AND ACT AS SPOKESMAN AT ANY CLUB FUNCTION. HE SHALL BE IN CHARGE OF PRESERVING THE PROPER ORDER AT ALL MEETINGS AND CAST THE DECIDING BALLOT IN THE EVENT OF AN EQUAL DECISION BEING VOTED UPON. HE SHALL ACT IN A RESPONSIBLE MANNER AND PERFORM HIS DUTIES IN THE BEST INTEREST OF THE CLUB. HE SHALL APPROVE OR APPOINT IF NECESSARY, AND OVERSEE ALL COMMITTEES AND FULFILL ALL OTHER DUTIES AS SET FORTH BY THESE BYLAWS.

VICE-PRESIDENT:

THE VICE-PRESIDENT SHALL ATTEND ALL MEETINGS AND SHALL ACT FOR THE PRESIDENT IN HIS ABSENCE AND SHALL ASSIST THE PRESIDENT IN THE PERFORMANCE OF HIS DUTIES.

SECRETARY:

THE SECRETARY SHALL ATTEND AND RECORD THE MINUTES OF ALL MEETINGS IN A BOOK FURNISHED FOR THAT PURPOSE. HE SHALL BE RESPONSIBLE FOR ALL CORRESPONDENCE REQUESTED BY THE PRESIDENT OR THE MEMBERSHIP. HE SHALL FULFILL ALL OTHER DUTIES AS SET FORTH BY THESE BYLAWS.

TREASURER:

THE TREASURER SHALL ATTEND ALL MEETINGS AND COLLECT ALL MONIES FOR THE CLUB. HE SHALL KEEP AN ACCOUNT OF ALL MONIES RECEIVED AND DISBURSEMENTS IN A BOOK FURNISHED FOR THAT PURPOSE. HE SHALL REPORT AT EACH MEETING THE STATE OF THE FUNDS OF THE CLUB AND PROVIDE AN ANNUAL REPORT OF INCOME AND EXPENSES FOR THE PRECEDING YEAR. HE SHALL FULFILL ALL OTHER DUTIES AS SET FORTH BY THESE BYLAWS.

Bylaws- Page 3 revision: 3 (article IMA.) (section 1)

SECTION 1.

ONLY THE PRESIDENT OR TREASURER MAY BE ELIGIBLE TO SIGN CHECKS IN CARRYING OUT CLUB FINANCES PROVIDED HE HAS MADE APPLICATION WITH THE BANK OR BANKS.

SECTION 2.

NO OFFICER SHALL SPEND ANY MONEY WITHOUT PRIOR APPROVAL OF THE MEMBERSHIP. A RECEIPT SHALL ACCOMPANY ALL BILLS, SUBMITTED FOR REIMBURSEMENT.

SECTION 3.

ALL OFFICERS SHALL BE RESPONSIBLE FOR ACQUIRING A PROXY TO REPRESENT THEMSELVES IF UNABLE TO ATTEND A REGULAR MEETING.

ARTICLE VI - TERM OF OFFICE

SECTION 1.

ALL OFFICERS OF "THE FLYING KNIGHTS OF HAMBURG, NEW YORK, INC." SHALL BE A ONE (1) YEAR TERM. THE TERM OF OFFICE SHALL BEGIN JANUARY FIRST.

SECTION 2.

AN OFFICER OF "THE FLYING KNIGHTS OF HAMBURG, NEW YORK, INC." MAY SERVE AS MANY ONE (1) YEAR TERMS IN OFFICE, PROVIDED HE IS NOMINATED, ELECTED OR RE-ELECTED BY MAJORITY VOTE OF THE MEMBERSHIP PRESENT AT THE REGULAR ELECTION MEETING, THE FIRST MEETING OF DECEMBER.

SECTION 3.

NO MEMBER SHALL BE ELIGIBLE TO BE A CLUB OFFICER UNLESS HE HAS BEEN A MEMBER OF THE CLUB FOR A PERIOD OF ONE (1) YEAR.

ARTICLE VII - VACANCIES

SECTION 1.

A VACANCY IN THE OFFICE OF VICE-PRESIDENT, SECRETARY, TREASURER OR BOARD MEMBER, SHALL BE FILLED BY MAJORITY VOTE OF THE MEMBERSHIP PRESENT AT ANY REGULAR MEETING. SUCH APPOINTEE TO SERVE IN THAT OFFICE UNTIL THE END OF THE TERM FOR WHICH HIS PREDECESSOR WAS ELECTED, PROVIDED ALL MEMBERS ARE NOTIFIED IN WRITING OF SPECIAL ELECTION AT LEAST THREE (3) DAYS IN ADVANCE OF SAID MEETING.

SECTION 2.

A VACANCY IN THE OFFICE OF PRESIDENT SHALL BE FILLED BY THE VICE-PRESIDENT, TO SERVE IN THAT OFFICE UNTIL THE END OF THAT TERM.

SECTION 3.

IF ANY OFFICER OR BOARD MEMBER, EXCEPT PRESIDENT, IS VACATED, A NOMINATING COMMITTEE SHALL BE MADE UP OF THE REMAINING BOARD OF DIRECTORS. FOLLOWING THE REPORT OF THE BOARD OF DIRECTORS, ANY CLUB MEMBER MAY NOMINATE HIS OWN CHOICE FROM THE FLOOR.

SECTION 4.

IF ANY OFFICER OR BOARD MEMBER CAN NOT OR DOES NOT FULFILL HIS OBLIGATIONS, HE MAY BE REPLACED THROUGH THE ABOVE PROCEDURES AT A TIME DESIGNATED BY THE BOARD OF DIRECTORS.

ARTICLE VIII - MEETINGS

SECTION 1.

REGULAR MEETINGS SHALL BE HELD EVERY THREE WEEKS ON FRIDAY, AS DETERMINED BY THE BOARD OF DIRECTORS AND APPROVED BY THE MEMBERSHIP.

SECTION 2.

BOARD MEETINGS TO BE DETERMINED BY THE BOARD OF DIRECTORS, USUALLY HELD THE TUESDAY BEFORE EACH REGULAR CLUB MEETING.

BYLAWS PAGE: 4 REVISION: A

SECTION 3.

SPECIAL MEETINGS OF THE CLUB SHALL BE AT ANY CONVENIENT TIME, UPON CALL BY THE PRESIDENT, OR UPON CALL SIGNED BY TEN MEMBERS OF THE CLUB, PROVIDED THAT ANY SUCH CALL SHALL NAME THE DATE, TIME, PURPOSE AND LOCATION OF SUCH A MEETING AND ALL MEMBERS SHALL BE NOTIFIED IN WRITING AT LEAST THREE (3) DAYS IN ADVANCE OF SAID MEETING.

SECTION 4.

THE ELECTION OF OFFICERS AND BOARD MEMBERS SHALL BE HELD ON THE FIRST MEETING OF DECEMBER. ALL MEMBERS SHALL BE NOTIFIED OF NOMINEES IN WRITING AT LEAST THREE (3) DAYS IN ADVANCE OF SAID MEETING.

SECTION 5.

THE NOMINATION OF OFFICERS AND BOARD MEMBERS SHALL BE HELD ON THE LAST MEETING OF NOVEMBER AND THE FIRST MEETING OF DECEMBER.

SECTION 6.

ALL REGULAR, BOARD AND SPECIAL MEETINGS SHALL BE CALLED TO ORDER AT 7:30 PM, UNLESS

ALL MEMBERS ARE NOTIFIED OTHERWISE.

SECTION 7.

A QUORUM IS REQUIRED FOR VOTING AT ALL MEETINGS.

ARTICLE IX - BOARD OF DIRECTORS

SECTION 1.

THE BOARD OF DIRECTORS SHALL CONSIST OF EIGHT MEMBERS; FOUR OFFICERS AND FOUR BOARD MEMBERS NOMINATED AND ELECTED BY THE MEMBERSHIP AT THE REGULAR ELECTION MEETING IN DECEMBER.

SECTION 2.

EACH MEMBER OF THE BOARD OF DIRECTORS EXCLUDING THE OFFICERS, WILL SERVE A TERM OF TWO YEARS. IF POSSIBLE, THE TERM WILL OVERLAP WITH OTHER BOARD MEMBERS TO ASSURE CONTINUITY.

SECTION 3.

THE BOARD MEMBERS WILL MEET IN CONJUNCTION WITH THE OFFICERS TO REVIEW ALL CLUB EXPENDITURES AND PROPOSALS AND MAKE SPECIFIC RECOMMENDATIONS FOR THE GOOD OF THE CLUB. THESE RECOMMENDATIONS WILL THEN BE VOTED ON BY THE GENERAL MEMBERSHIP FOR FINAL APPROVAL.

SECTION 4.

THE BYLAWS COMMITTEE WILL BE COMPRISED OF THE BOARD OF DIRECTORS. IT SHALL BE THE DUTY OF THIS COMMITTEE TO MAINTAIN THE CONSTITUTION AND BYLAWS, AND ALSO THE CLUB FIELD RULES. (SEE ARTICLE XIII - AMENDMENTS)

ARTICLE X - DUES AND FEES

SECTION 1A.

THE ANNUAL DUES TO THIS CLUB SHALL BE TEN DOLLARS (\$10.00) FOR THOSE HOLDING AN AMA OPEN LICENSE OR SENIOR LICENSE AND FIVE DOLLARS (\$5.00) FOR THOSE HOLDING AN AMA JUNIOR LICENSE.

SECTION IB.

IN ADDITION TO THE ANNUAL DUES, THE ANNUAL ASSESSMENT FEE TO THIS CLUB SHALL BE FORTY DOLLARS (\$40.00) TO ASSIST IN THE COST OF MAILING, MOWING AND CLUB EXPENSES. ANY CHANGE IN THE AMOUNT OF THIS ASSESSMENT FEE WILL BE DETERMINED AT THE FIRST MEETING IN OCTOBER OF EACH YEAR. IF MORE THAN ONE (1) MEMBER RESIDES IN THE SAME HOUSEHOLD, ONLY ONE (1) ASSESSMENT FEE OF FORTY DOLLARS (\$40.00) WILL PREVAIL FOR ONE (1) MEMBER. THE OTHER MEMBER OR MEMBERS WILL BE ASSESSED FIFTEEN DOLLARS (\$15.00) EACH.

SECTION 1C

ANNUAL DUES AND ANNUAL ASSESSMENT FEES BECOME PAYABLE ON NOVEMBER 1, AND MUST BE PAID BY JANUARY 31 TO REMAIN IN GOOD STANDING. IF NOT PAID BY JANUARY 31 OR IF MEMBER CANNOT PRODUCE A VALID AMA LICENSE OR VERIFICATION, HE WILL BE REMOVED FROM THE MEMBER-SHIP ROSTER AND A FIVE DOLLAR (\$5.00) INITIATION FEE WILL BE CHARGED TO REJOIN THE CLUB. EXTENUATING CIRCUMSTANCES MAY BE CONSIDERED BY THE MEMBERSHIP TO WAIVE THE INITIATION FEE FOR ANY ONE MEMBER. IN ANY EVENT, A MEMBERS ANNUAL DUES AND ANNUAL ASSESSMENT FEE MUST BE PAID IN ORDER TO EXERCISE THE RIGHT TO VOTE.

SECTION 1D.

THE TREASURER WILL NOT ACCEPT ANNUAL DUES OR ASSESSMENT FEES FROM ANY MEMBER OR NEW MEMBER UNTIL HE PRODUCES A VALID AMA LICENSE OR VERIFICATION OF MEMBERSHIP BY THE AMA, EXCEPT WHEN A MEMBER IS APPLYING FOR ASSOCIATE MEMBERSHIP, {SEE ARTICLE 111A, SECTION 1.)

SECTION 2.

INITIATION FEE TO THIS CLUB SHALL BE FIVE DOLLARS (\$5.00) AND MUST ACCOMPANY APPLICATION FOR MEMBERSHIP.

SECTION 3

TO RAISE THE ANNUAL DUES, ASSESSMENT OR INITIATION FEES, IT SHALL REQUIRE A MAJORITY VOTE OF NO LESS THAN FORTY PERCENT (40%) OF THE MEMBERSHIP, PROVIDED ALL MEMBERS ARE NOTIFIED IN WRITING OF SAID PROPOSAL AT LEAST THREE (3) DAYS IN ADVANCE OF SAID MEETING.

SECTION 4.

ANY PERSON WHO JOINS THE CLUB BEFORE JULY 1, SHALL PAY FULL DUES, ASSESSMENT FEE AND INITIATION FEE. AFTER JULY 1, DUES AND ASSESSMENT FEE WILL BE PRORATED MONTHLY. INITIATION FEE WILL BE PAID IN FULL.

SECTION 5.

THE BOARD OF DIRECTORS WILL NOT BE CHARGED ANNUAL DUES OR ASSESSMENT FOR THE YEAR FOLLOWING EACH TERM IN OFFICE.

SECTION 6.

THE NEWSLETTER ("THE KNIGHT FLYER") EDITOR AND ASSISTANT EDITOR SHALL NOT BE ASSESSED ANNUAL DUES OR ASSESSMENT FOR THE YEAR FOLLOWING EACH YEAR THEY HOLD THAT TITLE.

SECTION 7.

ALL HONORARY MEMBERS ARE EXEMPT FROM ANNUAL DUES AND CLUB FEES. THEY SHALL HAVE NO VOTE IN THE CLUB NOR HOLD ANY OFFICE IN THE CLUB.

SECTION 8.

THE BOARD OF DIRECTORS MAY UTILIZE UP TO TEN DOLLARS (\$10.00) PER MONTH OF THE CLUB'S FUNDS FOR MISCELLANEOUS ITEMS RELATED TO THE BOARD MEETINGS.

SECTION 9.

THE EDITOR OF THE CLUB NEWSLETTER, "THE KNIGHT FLYER", MAY DRAW UP TO ONE HUNDRED DOLLARS (\$100.00) FROM CLUBS FUND IN ADDITION TO SUPPLIES PER YEAR, FOR MAGAZINES AND OTHER PRINTED MATTER FOR THE PURPOSE OF PUBLISHING THE NEWSLETTER, WITH APPROVAL FROM THE BOARD OF DIRECTORS AND MEMBERSHIP.

SECTION 10.

THE CLUB MAY SPEND UP TO FORTY DOLLARS (\$40.00) TO SEND A GIFT TO ANY ILL OR DECEASED MEMBER, AFTER NOTIFYING THE PRESIDENT.

SECTION 11.

ALL ORIGINAL AND REGULAR LIFE TIME MEMBERS ARE OBLIGATED TO RENEW THEIR AMA MEMBERSHIP AND PAY THE CLUBS ANNUAL ASSESSMENT FEE EACH YEAR TO REMAIN IN GOOD STANDING.

SECTION 12.

TO ESTABLISH, ELIMINATE OR CHANGE ANY CLUB FUND, IT SHALL REQUIRE A MAJORITY VOTE OF NO LESS THAN FORTY PERCENT (40%) OF THE MEMBERSHIP, PROVIDED ALL MEMBERS ARE NOTIFIED IN WRITING OF SAID PROPOSAL AT LEAST THREE (3) DAYS IN ADVANCE OF SAID MEETING.

ARTICLE XI - NEWSLETTER "THE KNIGHT FLYER"

SECTION 1.

EDITOR: THE EDITOR WILL HAVE THE RESPONSIBILITY OF ORGANIZING, PUBLISHING AND DISTRIBUTING "THE KNIGHT FLYER" QUARTERLY, THE CLUB CALENDAR IN DECEMBER AND THE CLUB ROSTER IN MARCH. HE WILL ALSO DISTRIBUTE THE MEETING NOTICE POSTCARDS TO ALL MEMBERS AT LEAST ONE (1) WEEK BEFORE THE REGULAR MEETINGS.

SECTION 2.

ASSISTANT EDITOR: THE ASSISTANT EDITOR WILL ASSIST THE EDITOR WITH HIS DUTIES.

ARTICLE XII - DEFINITIONS

SECTION 1.

EQUIPMENT MANAGER: THE EQUIPMENT MANAGER IS RESPONSIBLE TO STORE, KEEP IN GOOD CONDITION, CHECK OUT AND KEEP A CLOSE RECORD OF ALL PROPERTIES OF THE CLUB, ASSIGNED TO HIM FOR SAFE KEEPING. THE EQUIPMENT MANAGER SHALL BE APPOINTED BY THE PRESIDENT AT THE BEGINNING OF HIS TERM IN OFFICE AND SHALL HOLD THIS POSITION UNTIL THE END OF THE YEAR. HE MAY SERVE AS MANY ONE (1) YEAR TERMS IN THIS POSITION, PROVIDED HE IS REAPPOINTED BY THE PRESIDENT AND ACCEPTS.

SECTION 2.

FIELD MARSHAL: THE FIELD MARSHAL SHALL BE RESPONSIBLE FOR POLICING, SAFETY, PARKING AND CROWD CONTROL AT ALL FIELD OUTINGS OR CLUB FUNCTIONS. HE MAY APPOINT AS MANY DEPUTIES NEEDED TO ASSIST IN HIS DUTIES. THE FIELD MARSHAL SHALL BE APPOINTED BY THE PRESIDENT AT THE BEGINNING OF HIS TERM IN OFFICE AND SHALL HOLD THIS POSITION UNTIL THE END OF THE YEAR. HE MAY SERVE AS MANY ONE (1) YEAR TERMS IN THIS POSITION, PROVIDED HE IS REAPPOINTED BY THE PRESIDENT AND ACCEPTS.

SECTION 3.

SPONSOR: A SPONSOR SHALL BE ANY MEMBER IN GOOD STANDING, WHO WILL BE RESPONSIBLE FOR INFORMING THE PROSPECTIVE MEMBER OF HIS OBLIGATIONS TO THE CLUB,

BYLAWS AND FLYING FIELD RULES AND REGULATIONS BEFORE HE IS VOTED INTO THE CLUB.

SECTION 4.

HONORARY MEMBER: ANY MEMBER OF OUTSTANDING ACHIEVEMENT AND DEVOTION TO THE CLUB, MAY BE SELECTED BY A MAJORITY VOTE OF NO LESS THAN FORTY PERCENT (40%) OF THE MEMBERSHIP PROVIDED ALL MEMBERS ARE NOTIFIED IN WRITING OF SAID PROPOSAL AT LEAST THREE (3) DAYS IN ADVANCE OF SAID MEETING. SECTION 5.

ARTICLE 1: RESIGNATION, TERMINATION, DISCIPLINARY ACTION, EXPULSION AND REINSTATEMENT OF MEMBERSHIP

- 1. ANY MEMBER IN GOOD STANDING MAY RESIGN HIS/HER MEMBERSHIP BY GIVING WRITTEN NOTICE TO THE CLUB.
- 2. IF ANY MEMBER CEASES TO HAVE THE QUALIFICATION NECESSARY FOR MEMBERSHIP IN THE AMA, HIS/HER MEMBERSHIP IN THE CLUB SHALL THEREBY TERMINATE, SUBJECT TO REINSTATEMENT UPON RESTORATION OF ELIGIBILITY.

 3. THIS SECTION PROVIDES FOR ENFORCEMENT OF THE SAFETY RULES THAT ARE RELATED TO FLYING ACTIVITIES. ANY OTHER UNACCEPTABLE BEHAVIOR BY AN INDIVIDUAL MEMBER OR MEMBERS, AS DEFINED BY THE BOARD OF DIRECTORS, BECOME THE RESPONSIBILITY OF THE BOARD OF DIRECTORS AS STATED IN ARTICLE V DUTIES OF THESE BYLAWS. ANY INDIVIDUAL MAY BE EXPELLED FROM MEMBERSHIP FROM THE CLUB BY A TWO-THIRDS (2/3) MAJORITY VOTE OF THE BOARD OF DIRECTORS IF, IN THE BOARD OF DIRECTORS DETERMINATION, SUCH INDIVIDUAL WILLFULLY COMMITS ANY ACT OR OMISSION WHICH IS A VIOLATION OF ANY OF THE TERMS OF THESE ARTICLES OF INCORPORATION AND BYLAWS, OR THE RULES OF THE AMA, OR WHICH IS DETRIMENTAL TO THE CLUB, THE AMA OR TO MODEL AVIATION.
- 4. ANY MEMBER WHO IS EXPELLED FROM MEMBERSHIP MAY BE REINSTATED TO MEMBERSHIP ONLY BY TWO-THIRDS (2/3) MAJORITY VOTE OF THE BOARD OF DIRECTORS
- 5. THE BOARD OF DIRECTORS SHALL HAVE THE DISCRETIONARY AUTHORITY TO PROVIDE FOR AND TO IMPOSE DISCIPLINARY ACTION FOR SUCH ACTS OR OMISSIONS, WHICH DO NOT JUSTIFY EXPULSION FROM MEMBERSHIP.

ARTICLE 2: DISSOLUTION

- THE CORPORATION MAY BE DISSOLVED WITH THE APPROVAL OF A TWO-THIRDS (2/3)
 MAJORITY VOTE OF THE TOTAL MEMBERSHIP.
- UPON THE DISSOLUTION OF THE CORPORATION, THE BOARD SHALL, AFTER PAYING OR MAKING PROVISION FOR THE PAYMENT OF ALL OF THE LIABILITIES OF THE CORPORATION, DISPOSE OF ALL THE ASSETS OF THE CORPORATION EXCLUSIVELY FOR THE PURPOSES OF THE CORPORATION IN SUCH MANNER, TO THE ACADEMY OF MODEL AERONAUTICS, INC., OR TO SUCH OTHER ORGANIZATION OR ORGANIZATIONS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, RELIGIOUS OR SCIENTIFIC PURPOSES AS SHALL AT THE TIME QUALIFY AS AN EXEMPT ORGANIZATION OR ORGANIZATIONS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, OR TO SUCH OTHER ORGANIZATION WITH PURPOSES SIMILAR TO THE PURPOSES OF THIS CORPORATION, AS THE BOARD SHALL DETERMINE. ANY OF SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY THE COURT OF COMMON PLEAS (OR SIMILAR COURT) OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THIS CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES AND TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.

ARTICLE 3: GRIEVANCE PROCEDURE (FLIGHT AND GROUND SAFETY RULES)

1. PURPOSE

THE GRIEVANCE PROCEDURE PROVIDES A MECHANISM TO ENFORCE EXISTING SAFETY RULES BY PROVIDING A PROGRESSIVE DISCIPLINARY SYSTEM WHEN NEEDED. ALTHOUGH MOST COMPLAINTS CAN BE RESOLVED INFORMALLY, IF A COMPLAINT IS SERIOUS OR CANNOT BE RESOLVED INFORMALLY, THE MATTER SHOULD BE REFERRED TO THE SAFETY COMMITTEE FOR ITS CONSIDERATION BY MEANS OF A GRIEVANCE FORM TO BE FILLED OUT AND TURNED INTO THE SAFETY COMMITTEE CHAIRMAN. AT LEAST ONE WITNESS IS REQUIRED TO SIGN THE GRIEVANCE FORM.

2. SAFETY COMMITTEE

THE SAFETY COMMITTEE SHALL USE ITS JUDGEMENT IN CARRYING OUT ACTION ON THE FOLLOWING:

(A) A GRIEVANCE FORM WILL BE FILLED OUT AND TURNED INTO THE SAFETY COMMITTEE CHAIRMAN. AT LEAST ONE WITNESS IS REQUIRED.

(B) FIRST VIOLATION

- A. VIEWPOINTS OF BOTH COMPLAINANTS AND ACCUSED WILL BE CONSIDERED.
- B. COMPLAINANTS NAME WILL BE DISCLOSED.
- C. A VERBAL REPRIMAND WILL BE GIVEN TO THE ACCUSED BY THE SAFETY COMMITTEE, AND THIS WILL BE RECORDED IN THE COMMITTEE FILES.

(C) SECOND VIOLATION

- A. COMPLAINANTS NAME WILL BE DISCLOSED.
- B. THE ACCUSED HAS THE RIGHT TO A WRITTEN REBUTTAL, TO BE REVIEWED BY THE COMMITTEE.
- C IF THE COMMITTEE SO DECIDED, THE FLYING PRIVILEGES OF THE ACCUSED WILL BE SUSPENDED FOR THIRTY (30) DAYS. WRITTEN NOTICE OF THIS SHALL BE ISSUED AND A COPY PUBLISHED IN THE CLUB NEWSLETTER.

(D) THIRD VIOLATION

- A. COMMITTEE WILL NOTIFY THE ACCUSED IN WRITING AND THE CLUB MEMBERS VIA THE CLUB NEWSLETTER THAT THE CLUB WILL VOTE ON THE EXPULSION OF THE ACCUSED AT THE NEXT MEETING.
- B. SAID EXPULSION WILL LAST FOR A ONE-YEAR MINIMUM. (LONGER IF DEEMED NECESSARY BY THE BOARD OF DIRECTORS).
- C. A MEMBER MAY BE EXPELLED FROM THE CLUB ONLY UPON A TWO-THIRDS (2/3) MAJORITY VOTE OF THE MEMBERSHIP PRESENT AT THE MEETING.
- D. VOTING WILL BE BY SECRET BALLOT AT A REGULAR MONTHLY MEETING.
- E. THE EXPELLED MEMBER MAY REAPPLY FOR MEMBERSHIP AFTER THE EXPIRATION OF THE EXPULSION TIME PERIOD.
- (E) THE THREE ACTIONS WILL NOT BR ENFORCED UNLESS THEY ARE ACCUMULATED WITHIN A TWO-YEAR PERIOD OF TIME.
- (F) ANY MEMBER RECEIVING A GRIEVANCE, WHO DIRECTS ANY RETALIATION ACTION AGAINST THE PERSON FILING SAID GRIEVANCE, WILL BE SUBJECT TO IMMEDIATE EXPULSION FROM THE CLUB. THIS IS TO INCLUDE THREATS, INTIMIDATION, PHYSICAL HARM, INTENTIONAL EQUIPMENT DAMAGE, OR ANY OTHER ACTION DEEMED TO BE RETALIATORY BY THE BOARD OF DIRECTORS.

SECTION 6.

QUORUM: A QUORUM SHALL BE TWENTY-FIVE PERCENT (25%) OF THE MEMBERSHIP AT ANY SPECIAL OR REGULAR MEETING AND AT LEAST THREE (3) BOARD OF DIRECTORS AT ANY BOARD MEETING.

SECTION 7A.

COMMITTEES: THE COMMITTEES OF THE CLUB SHALL BE APPROVED, OR APPOINTED IF NECESSARY, BY THE PRESIDENT AT THE BEGINNING OF HIS TERM IN OFFICE, TO SERVE UNTIL THE END OF THE YEAR. THEIR DUTIES SHALL BE INDICATED BY THE NAMES OF THE COMMITTEES.

SECTION 7B.

ALL REPORTS OF COMMITTEES WHEREIN MONEY IS EXPENDED OR RECEIVED SHALL BE IN WRITING, SIGNED BY A COMMITTEE MEMBER OR ITS CHAIRMAN, AND SHALL BE READ BY THE COMMITTEE CHAIRMAN AND PROPERLY FILED BY THE TREASURER. ALL RECEIPTS FOR EXPENDITURES MUST ACCOMPANY THE REPORT.

SECTION 7C.

ANY MEMBER OR COMMITTEE MEMBER SUGGESTING A NEW PROPOSAL OR EXPENSE DIFFERING FROM THE PREVIOUS YEAR, MUST PRESENT AND EXPLAIN NEW THE PROPOSAL AND EXPENSE TO THE BOARD OF DIRECTORS FOR THEIR EVALUATION AND RECOMMENDATION. IT SHALL THEN BE PRESENTED AND VOTED ON BY THE GENERAL MEMBERSHIP FOR FINAL APPROVAL.

ARTICLE XIII - NORTH COLLINS FIELD

THE NORTH COLLINS FIELD, LOCATED ON EDEN ROAD OFF SHIRLEY ROAD IN NORTH COLLINS, NEW YORK, IS OWNED BY THE FLYING KNIGHTS OF HAMBURG, NEW YORK INC. THE FIELD WAS PURCHASED BY MONIES RECEIVED BY OFFERING "ORIGINAL LIFE TIME MEMBERSHIPS" AT ONE HUNDRED FIFTY DOLLARS (\$150.00) EACH AND THE BALANCE FROM THE CLUB TREASURY.

SECTION 1.

IN THE EVENT THE CLUB IS TO BE DISBANDED, THE FIELD WILL BE SOLD AND \$150.00 WILL BE PAID BACK TO EACH ORIGINAL LIFE TIME MEMBER OF KNOWN WHERE ABOUTS. THE REMAINDER OF SALE WILL REVERT TO THE CLUB TREASURY AND DIVIDED EQUALLY AMONG ALL MEMBERS (EXCLUDING HONORARY MEMBERS) AT THE TIME OF DISBANDING.

SECTION 2.

IN THE EVENT THE NORTH COLLINS FIELD MUST BE DISPOSED OF FOR ANY OTHER REASON, \$150.00 WILL BE PAID TO EACH ORIGINAL LIFE TIME MEMBER OF KNOWN WHERE ABOUTS AND THE REMAINDER OF THE MONIES WILL GO BACK INTO THE CLUB TREASURY TO BE USED FOR NORMAL CLUB BUSINESS ACTIVITIES.

SECTION 3.

IN THE EVENT AN ORIGINAL LIFETIME MEMBER BECOMES INACTIVE OR LEAVES THE AREA, HE MUST KEEP THE CLUB POSTED <u>ANNUALLY</u> AS TO HIS WHERE ABOUTS BY NOTIFYING THE CLUB AT THE PERMANENT ADDRESS. IF HE DOES NOT DO THIS, AND IF THE NORTH COLLINS FIELD IS DISPOSED OF, HIS \$150.00 WILL REVERT TO THE CLUB TREASURY.

SECTION 4.

ANY REFUNDS AS PREVIOUSLY EXPLAINED, WILL BE PAID TO THE ACTUAL NAMED $\underline{\mathsf{MEMBER}}$ ONLY.

SECTION 5.

IF THE FIELD IS DISPOSED OF AND THE CLUB IS STILL INTACT, THE ORIGINAL LIFE TIME MEMBERS MAY HAVE THE CHOICE OF REMAINING A LIFE TIME MEMBER OR RECEIVING HIS SHARE OF \$150.00. IF HE ACCEPTS HIS \$150.00, HIS ANNUAL DUES WILL BECOME DUE ON THE NEXT DUE DATE.

SECTION 6.

IF THE NORTH COLLINS FIELD IS DISPOSED OF FOR ANY REASONS, AND A LOSS IS REALIZED FROM THE ORIGINAL PURCHASE PRICE, THE MONEY RECEIVED FROM THE SALE WILL BE DIVIDED EQUALLY AMONG THE ORIGINAL LIFE TIME MEMBERS OF KNOWN WHERE ABOUTS PROVIDED IT DOES NOT EXCEED \$150.00 PER ORIGINAL LIFETIME MEMBER.

SECTION 7.

RULES FOR THE NIKE FLYING SITE, HAMBURG, N.Y.

Transmitters must be off and left in the impound rack with the antenna collapsed, unless you have a frequency pin and are ready to ground check or fly.

All flyers must have frequency flags on the transmitter antenna. The frequency pin must be attached to transmitter. Possession time for the pin is limited to 20 minutes. NO EXCEPTIONS

Safety or pre-flight checks must be done before each first flight of a session.

All Radio Controlled Model Aircraft must have owners ID-label in or on the model to be covered by AMA Insurance.

Every pilot must have a current AMA license and place it in the proper card holder before taking a frequency pin.

Take-off and landing will always be parallel to the flight line, regardless of wind conditions.

All pilots will use the designated flight stations.

Flying behind the flight line, over the pit area or Soccer Fields, near the road or buildings, especially the Arena, is prohibited.


All model aircraft are limited to a maximum altitude of 400 feet at the Nike Site, because of the local airport.

After landing, a pilot may taxi his aircraft back to the flight line only.

Immediately, upon landing, all pilots will remove planes from the field and return to the pit area. Lingering on the field will not be tolerated for your own safety.

Alcoholic beverages at the Nike Site are prohibited. THIS IS A TOWN OF HAMBURG ORDINANCE.

The AMA Safety Code and Town of Hamburg Rules also apply.



NORTH COLLINS FIELD RULES

- 1. All members must have current AMA license with him while flying and show it on request. He must abide by the field rules and the AMA safety code at the the North Collins field.
- 2. All Radio Controlled Model Aircraft must have owners ID label in or on the model to be covered by AMA Insurance.
- 3. Engines must meet noise requirements of 98 decibels at 9ft. taken at 4 points with average reading.
- 4. No internal combustion engines to be run before 10:00 a.m.
- 5. pit area will be on South side of field at all times.
- 6. All flyers must have frequency flags on the transmitter antenna, Frequency pin must be attached to transmitter before it is turned on.
- 7. Transmitter antenna must be collapsed, unless you have a frequency pin and are setting up for flying.
- 8. All flyers will use the designated flight stations.
- 9. Frequency pin possession is limited to 20 minutes, including start-up, when others are waiting on the same frequency. NO EXCEPTIONS.
- 10. Take-off and landing will <u>always</u> be parallel to the flight line, regardless of wind conditions. Taxiing closer than 10 ft. of pits, after landing, is not allowed.
- 11. Flying over the pit area, spectators, Horse Corrals or parking area is prohibited. Flying over the the home Southwest of the field or any other building is <u>strictly prohibited</u> at any time.
- 12. Only 4 airplanes are permitted in the air at any time.
- 13. No aircraft will be flown or tested, if there is a known or obvious defect with the model or equipment.

- 14. Immediately, after landing, pilot will remove his plane from the field. lingering on the field will not be tolerated for your own safety.
- 15. Each flyer will turn his transmitter off at the end of his flight and announce the fact to those on the same frequency.
- 16. Safety or preflight checks will be done before each first flight of a flying session.
- 17. novice pilots shall fly only with an instructor, until takeoffs and landing can be done safely. The Club has a list of qualified instructors.
- 18. Non-members are welcome, if they are with a Club member, and are AMA members. They must abide by the rules and have a current AMA license.
- 19. Members are responsible for the safety at the field and should take corrective action against unsafe conduct.
- 20. Each member is responsible for his own litter.
- 21. Unleashed animals are not permitted at the field.
- 22. Alcoholic beverages are not allowed at the North Collins field.
- 23. Failure to comply with these rules may result in being expelled from the Club and/or banned from using the field.
- 24. Refer to enclosed diagram for flight pattern.
